### Notice of Proposed Parking Places Order

---

#### THE THREE RIVERS (RICKMANSWORTH) (OFF-STREET PARKING PLACES) ORDER 2006 (AMENDMENT NO.3) ORDER 201Y

---

**NOTICE IS HEREBY GIVEN** that the Three Rivers District Council, acting as agents for the Hertfordshire County Council and after consultation with the Chief Officer of Police proposes to make the above named Orders under the Road Traffic Regulation Act 1984.

Full details of these proposals are set out in the draft Orders which, together with plans and a statement of reasons for proposing to make the Orders, can be examined during normal opening hours at the Council's offices in Rickmansworth. Details can also be viewed on the Council's web site at [www.threerivers.gov.uk](http://www.threerivers.gov.uk)

The effects of this order would be to implement decisions taken by the District Council to:

- Introduce 1 hour of free parking in eight car parks in Rickmansworth, changing these car parks from 2-hour to 4-hour maximum stay
- Introduce charges for parking for longer in those car parks, at £1 for the 2nd hour £2.50 for the 3rd hour and £4 for up to 4 hours.
- Change the service provided at the Northway (lower deck) car park to long-stay (maximum stay 24-hours) at £4 per day
- Change the service provided at the Talbot Road (High Street) car park to 4-hour stay, with one hour free parking
- Introduce new parking payment mechanisms that do not accept the use of cash.

**Statement of Reasons for Proposed Order**

**THE THREE RIVERS (RICKMANSWORTH) (OFF-STREET PARKING PLACES) ORDER 2006  
(AMENDMENT NO.3) ORDER 201Y**

The District Council has determined, following a detailed study into use of the short-stay car parks in Rickmansworth, that in support of the objective to increase the turnover of vehicles using this short-stay parking it intends to introduce charging for parking beyond the first hour, which will remain free of charge. This measure is intended to support local retail services by providing more opportunity for visitors to find short-stay parking and to encourage greater turnover of visitors to the shops.

**THE THREE RIVERS (RICKMANSWORTH) (OFF-STREET PARKING PLACES)  
ORDER 2006 (AMENDMENT NO.3) ORDER 201Y**

---

The Three Rivers District Council (hereon cited as “the Council”), under arrangements made with the Hertfordshire County Council pursuant to Section 19 of the Local Government Act 2000 and the Local Authorities (Arrangements for the Discharge of Functions) (England) Regulations 2012, and in exercise of the powers conferred on that County Council under Sections 1,2,3,4,32,35,45,46,47, 49 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereon cited as “the Act of 1984) and all other enabling powers, and in accordance with the relevant provisions of the Traffic Management Act 2004 and having consulted the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. This Order may be cited as *The Three Rivers (Rickmansworth) (Off-Street Parking Places) Order 2006 (Amendment No.3) Order 201Y* and shall come into operation on the **DD/MM/20YY**
2. This Order amends *The Three Rivers (Rickmansworth) (Off-street Parking Places) Order 2006* (as amended), hereon cited as “the 2006 Order”.
3. This Order amends *The Three Rivers (Three Rivers House Staff And Councillor Car Park) (Off-Street Parking Places) Order 2015*.
4. This Order amends the *Three Rivers District Council Three Rivers (Off-Street Parking Places) Order 1994*.
5. This Order replaces Schedule 1 of the 2006 Order (Short Stay car parks up to 2 hours) with Schedule 1 of this Order.
6. This Order inserts Schedule 1A of this Order beneath Schedule 1 of the 2006 Order (Short-stay car parks subject to charges).
7. This Order expands the List of schedules in the 2006 Order to include a line referencing the inserted Schedule 1A.
8. This Order removes Part 1 (a) of Schedule 2 of the 2006 Order (“*Ten spaces marked in Bury Lane car park, Bury Lane, Rickmansworth*”).
9. This Order replaces Part 2 of Schedule 2 of the 2006 Order to state: “*Free in Parking Places (b) and (c)*”.
10. This Order inserts into Article 20(1) of the 2006 Order, after the word “Schedules”, the wording “**1,**”.

11. This Order replaces Article 11(2) of the 2006 Order with the following Article 11(2): *Parking places referred to in Schedule 1 may be used for the leaving during the permitted hours of such vehicles of the class specified in paragraph (1) above when a valid parking ticket is displayed in the manner specified in Article 20(1), for no longer than a period of 2 hours and not return to the same parking place within a period of 1 hour.*
12. This Order inserts the following Article after Article 11(2) of the 2006 Order as Article 11(2A): *“Parking places referred to in Schedule 1A may be used for the leaving during the permitted hours of such vehicles of the class specified in paragraph (1) above for no longer than a period of 4 hours and with no return to the same parking place within a period of 1 hour”.*
13. This Order replaces Part 1 (d) of Schedule 3 of the 2006 Order with the words: “Northway Multi-storey car park Lower Storey, Northway, Rickmansworth.”
14. This Order modifies Schedule 2 of *The Three Rivers (Three Rivers House Staff And Councillor Car Park) (Off-Street Parking Places) Order 2015* by deleting the word ‘Saturday’ from Items 1 to 6.
15. The restrictions imposed by this Order shall be in addition to, and not in derogation of, any restriction or requirement imposed by any regulation made or having effect as if made under the Act of 1984 or by or under any other enactment.

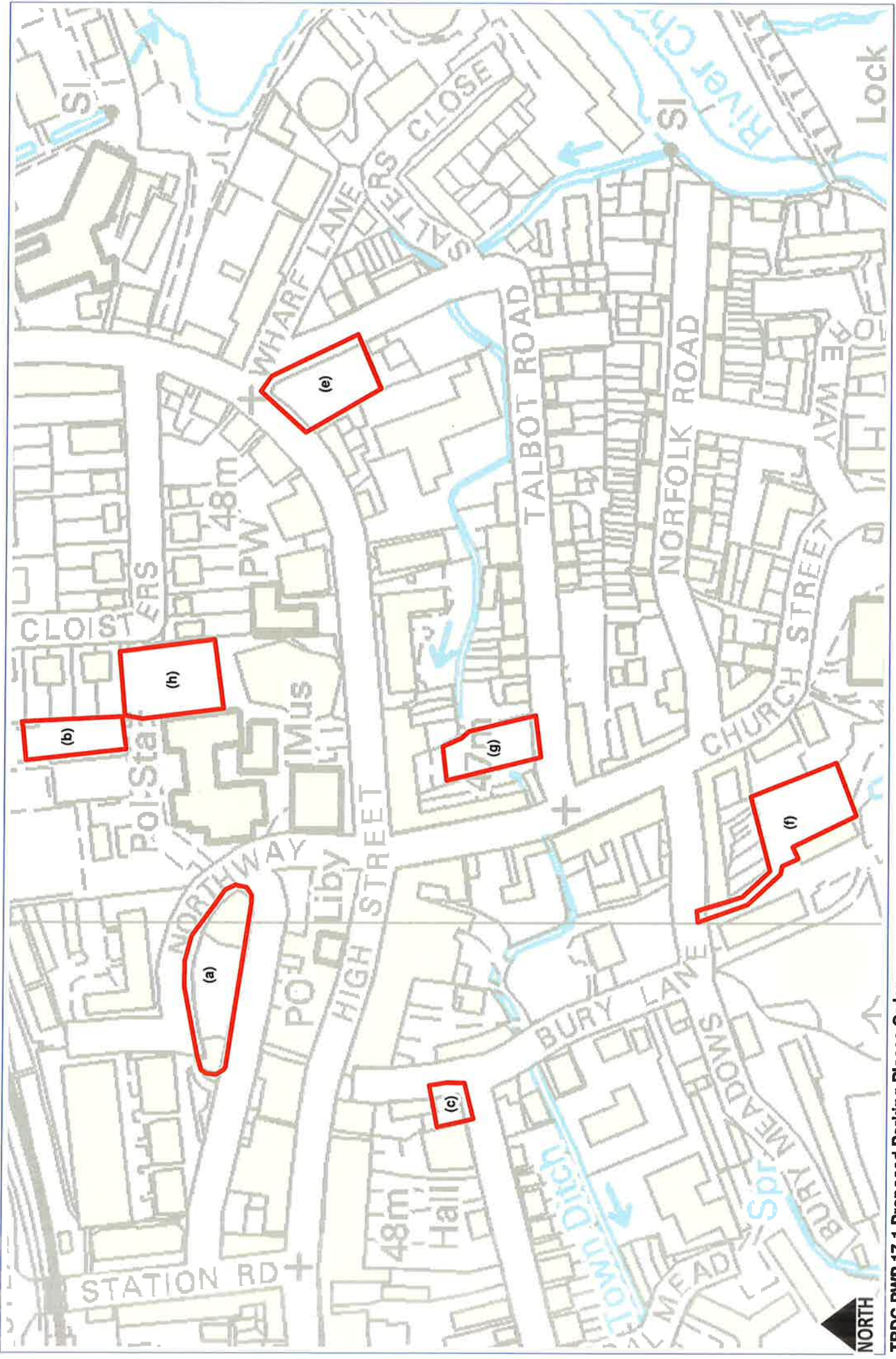
